### Review of the Recommended Variety List

The 22 recommended varieties below were identified as exceeding the regional smut threshold (>6) and were removed from the ratooning only list:

- CP44-101, H56-752, PINDAR, Q87, Q110, Q117, Q121, Q123, Q136, Q153, Q157, Q159, Q170, Q185<sup>Ⓛ</sup>, Q189<sup>Ⓛ</sup>, Q196<sup>Ⓛ</sup>, Q197<sup>Ⓛ</sup>, Q205<sup>Ⓛ</sup>, Q207<sup>Ⓛ</sup>, Q221<sup>Ⓛ</sup>, Q227<sup>Ⓛ</sup>. RB76-5418 was also highlighted for removal noting its susceptibility to chlorotic streak.

Other varieties on the Planting and Ratooning list were also reviewed by the committee;

- SRA1<sup>Ⓛ</sup> (low fibre), SRA2<sup>Ⓛ</sup>, Q142 (not grown), Q151, Q171 (high pachymetra, low TCH), Q177<sup>Ⓛ</sup> (high pachymetra, low TCH), Q237<sup>Ⓛ</sup>, Q245<sup>Ⓛ</sup> (floc), Q246<sup>Ⓛ</sup> (red rot).

### Decisions:

1. Q142, Q151, Q245<sup>Ⓛ</sup> and SRA1<sup>Ⓛ</sup> all to be removed from the planting and ratooning list.
2. SRA2<sup>Ⓛ</sup> and Q237<sup>Ⓛ</sup> to be reviewed by observing performance in other regions.

3. Q171, Q177, Q209<sup>Ⓛ</sup> and Q246<sup>Ⓛ</sup> change status to ratooning only with additional sunset clause for removal from list in 2020.
