### Review of the Recommended Variety List

Review of the current approved list indicated that four varieties Q229<sup>Ⓛ</sup>, Q199<sup>Ⓛ</sup>, Q164 and CASSIUS currently approved for planting and ratooning exceed the region rating for leaf scald (>6.5).

**Decision:** Change Q229<sup>Ⓛ</sup>, Q199<sup>Ⓛ</sup>, Q164 and CASSIUS to ratooning only status.

The recommended variety list was reviewed with old varieties no longer sent to the mill (2017) removed from the list.

The following varieties were voted to be removed from the recommended list Argos<sup>Ⓛ</sup>, BADILA, H56-752, Mida<sup>Ⓛ</sup>, Q57, Q77, Q99, Q100, Q107, Q115, Q119, Q121, Q122, Q124, Q127, Q128, Q129, Q130, Q132, Q141, Q142, Q149, Q157, Q158, Q161, Q162, Q165, Q170, Q171, Q173<sup>Ⓛ</sup>, Q175<sup>Ⓛ</sup>, Q178<sup>Ⓛ</sup>, Q179<sup>Ⓛ</sup>, Q181<sup>Ⓛ</sup>, Q188<sup>Ⓛ</sup>, Q192<sup>Ⓛ</sup>, Q194<sup>Ⓛ</sup>, Q195<sup>Ⓛ</sup>, Q233<sup>Ⓛ</sup>.

**Decision:** Remove these 39 varieties from the Northern RVC recommended variety list.
