## Appointment of proxy (see Proxy Form)

- **To appoint a single proxy** – complete name of proxy in Section 2 and sign the Proxy Form, **OR**
- **To appoint the Chair only** – if you want to appoint the Chair of the meeting as your proxy, just leave Section 2 blank and sign the Proxy Form.

A proxy appointed to attend and vote for a Member has the same rights as the Member to vote (to the extent allowed by this appointment) and to join in the demand for a poll.

## How to sign the Proxy Form

- A Member Representative may sign this Proxy Form on behalf of the relevant Member he/she represents.
- The Proxy Form must be signed by the Member or by its Member Representative in the presence of a witness who must also sign the Proxy Form.
- If a joint membership, then all individual Members must sign.
- If the Proxy Form is signed by a person who is not the registered Member, or Member Representative, then the relevant authority in original form or a certified copy of such original form of the relevant authority should either have been sent previously to SRA for recording or be enclosed with this Proxy Form. If sent by fax then the authority must be certified.
- If the Member is a corporation, the Proxy Form must be signed in accordance with its constitution and the *Corporations Act 2001* (Cth), or under the hand of an authorised officer or attorney who has not received any notice of revocation. A person intending to vote on behalf of a corporation **MUST** bring a properly executed authority from the corporation in favour of the person attending.
