

2020/21 RESEARCH INVESTMENTS – TENDERS AND EXPRESSIONS OF INTEREST APPLICATION KIT

Sugar Research Australia (SRA) supplies this application kit to assist applicants with tenders and EOIs in response to SRA’s research project call.

Applications will be assessed by SRA’s Research Funding Panel (RFP) which will provide investment recommendations to the SRA Board. The assessment process is highly competitive, and it is important that applications are as detailed and validated as possible. Therefore, it is strongly suggested that, as the applicant, you should: -

1. Read and comply with the contents of this application kit.
2. Provide detailed references for reports, books and/or journals that support your arguments for the innovation, background, and methods to be used within your project, using either the Harvard or Vancouver referencing system.
3. Identify and describe objectives and achievement criteria for milestones that are S.M.A.R.T (Specific, Measurable, Achievable, Realistic, and Time related) and demonstrate progress towards the delivery of project outcomes.
4. Provide details (names, positions, phone numbers and email addresses) of industry people consulted in the preparation of your application or who will be consulted during the project.
5. Fully justify all aspects of the funding requested, but especially detail your salary requests: include a rationale for the requested FTEs (their intended role as well as their expertise) of all staff allocated to the project. If travel funds are requested, include a rationale for how the travel will support the achievement of project objectives. No international conference travel should be included in the budget. Describe the major inclusions in the requested operating costs and justify the expenditure required in terms of the delivery of project outputs and outcomes.
6. Describe in detail the outcomes achieved in your past or current projects that may form a basis or background for this application.

Instructions for completing the application through SugarNet

Activity and Milestone Timeline Template

This template will assist you to identify and list the various project activities and their duration. It can also provide a basis for identifying critical dates during each financial year where meaningful milestones (usually two per year) can be inserted and supported by assessable achievement criteria. Milestones should involve key project stages and/or deliverables. Milestone achievement criteria should be in dot point form and enable the assessment of progress towards Project Objectives, Outputs and Outcomes in the context of that milestone. This template must be completed and uploaded as an attachment through SugarNet.

Milestone Budget Calculator Template and the Budget

During the assessment of application, project budgets will be examined and assessed in the context of proposed activities. It is important that reasonable estimates of costs are used to develop project budgets which provide value-for-money research investments for SRA. The budget calculator is to facilitate your budget preparation and assist the project review process. This template must be completed and uploaded as an attachment through SugarNet.

The Intellectual Property (IP) Register

The IP Register is an important document for all projects. The objective of the IP Register is to list all IP required for the project (Background IP (BIP) and Third-Party IP (TPIP)) as well as IP which will be developed within the project (Project IP (PIP)), including project data and documents. Failure to adequately disclose this information or providing incomplete/false information will affect SRA's investment decision. The IP Register must also include details of IP rights and any restrictions which may apply for the use of any IP to deliver project outcomes.

To create efficiencies in recording, tracking, and reporting IP elements, SRA has implemented

the software package Minuet™ to manage IP. Minuet™ is a new enterprise ecosystem from Inteum Company to help us manage our intellectual property portfolio. This Portal allows access to an online IP Disclosure form that includes all key requirements of the SRA IP Register.

The IP SOP document has been provided to help complete the IP Disclosure form. This document can be downloaded from the SugarNet also. Access to the portal and instructions including an instructional video can be found at <https://sugarresearch.com.au/research-investment/intellectual-property/>.
