- if required, agrees to provide to SRA an annual return in the form specified by SRA, to enable SRA to confirm its eligibility for continued membership and determine its voting entitlement;
- nominates the person named above as its Member Representative;
- nominates its Member Representative's 'preferred method of contact' (address, email address) as the address or email address to which the Applicant will receive all notices and communications from SRA;
- authorises the Member Representative to receive all notices and communications on behalf of the Applicant, to do all things required by the Applicant under the Constitution and to attend meetings and vote on the Applicant's behalf;

<b>Group M</b>	MILL COMPANIES which have paid a Sugarcane Levy during the current or previous calendar year	1 vote plus 1 vote per whole tonne of Sugarcane delivered to the Member's Processing Plant(s) in the prior calendar year*

**Growing Business** means a business in Australia with an ABN that grows sugarcane for processing by a Processing Plant.

**Mill Company** means an entity (including an Associates of an entity) operating one or more Processing Plants.

**Processing Plant** means a facility or premises that take delivery of at least 3,000 tonnes of sugarcane in a calendar year and processes sugarcane into any subsequent product or form.

**Sugarcane Statutory Levy** means a levy imposed under the *Primary Industries (Excise) Levies Act 1999* (Cth) on Processors (an entity that operates a Processing Plant) and Growing Businesses.

Other terms used throughout this form are defined in the Constitution. Our Constitution is available on our website [www.sugarresearch.com.au](http://www.sugarresearch.com.au). Hard copies are available upon request.

\*On a show of hands, each Member Representative present has 1 vote.

If eligible, you will automatically be admitted to membership. If you become eligible you will automatically be removed from membership. You may resign from membership by notice in writing to the SRA Board. Membership is not transferable. Membership of SRA is your entitlement as a Sugarcane Levy payer. There are no entrance or membership fees.

If you are a natural person, you will be automatically deemed to be the Member Representative. If you are not a natural person, you must nominate a natural person to represent you. Your Member Representative is entitled to do all things required by you under the Constitution and to attend meetings and vote on your behalf. You may revoke or amend the appointment of your Member Representative at any time by notice in writing to the SRA Board.

**PRIVACY AND CONFIDENTIALITY**

The information you provide in this form may include personal information under the *Privacy Act 1988*. The information is collected for the purpose of processing your application for membership and communicating with you in relation to your membership and our business. If you do not provide the information requested, we may be unable to admit you to membership.
