

TERMS AND CONDITIONS OF SRA WEED SURVEY GIVEAWAY

GENERAL

For the purpose of these Terms and Conditions, the promoter is Sugar Research Australia Limited (SRA), ACN 163 670 068 L10, 300 Queen Street, Brisbane QLD 4000.

These Terms and Conditions set out the terms for the **SRA Weed Survey Giveaway**. Upon completion of the **SRA Weed Survey**, you have a choice to then enter the **SRA Weed Survey Giveaway**. Should you choose to provide your details as part of your entry, you are confirming that you accept and comply with these Terms and Conditions.

If there is any inconsistency between these Terms and Conditions and anything else that refers to this giveaway contest, these Terms and Conditions will prevail.

1. ELIGIBILITY AND PARTICIPATION

- 1.1. Entry is open to anyone who is over the age of 18 years and an Australian Sugarcane Levy payer within Australia's sugarcane districts (Queensland and Northern NSW) (**eligible entrant**).
- 1.2. Subject to your compliance with these Terms and Conditions, SRA will enter the eligible entrant into the drawer for a chance to win one (1) of 50 Nufarm Dropzone 20 litre drums. No purchase is required.
- 1.3. This giveaway contest commences on 29th April 2024 and closes on 1st March 2025 at 11:59 pm AEST.
- 1.4. Only one (1) entry is permitted per eligible entrant.
- 1.5. This is a game of chance and skill plays no part in determining the winner. The winning entries will be selected at random by SRA.
- 1.6. The prize for each individual will only be delivered to the individual's nominated address as provided, which must be within Australia's sugarcane districts (Queensland and Northern NSW).
- 1.7. Entry into the *SRA Weed Survey Giveaway* is not available to employees and immediate families of Sugar Research Australia Limited or SRA board members.
- 1.8. Where you meet the requirements of entry you, upon completion of the *SRA Weed Survey*, will be provided a link to an online form to enter your name and contact details to be entered in the drawer for the *SRA Weed Survey Giveaway*.
- 1.9. Eligible Australian Sugarcane Levy payers should only complete the *SRA Weed Survey* once. The eligible entrant will receive one (1) entry into the *SRA Weed Survey Giveaway* for completing the *SRA Weed Survey*.
- 1.10. SRA in no way makes any guarantee of the availability of its web services and will not be held responsible for interruption of service that may interfere with the ability to participate in the *SRA Weed Survey* and/or the *SRA Weed Survey Giveaway*.

2. NOTIFICATION OF WINNING ENTRANTS

- 2.1. The first round of 10 individual winning entrants will be drawn randomly from the total pool of entrants before 2nd July 2024 at SRA offices on Level 10, 300 Queen Street, Brisbane 4000. SRA's decision will be final and no correspondence will be entered into. The remaining 40 individual winning entrants will be drawn randomly from the total pool of entrants before/on 1st March 2025 at SRA offices on Level 10, 300 Queen Street, Brisbane 4000. SRA's decision will

be final and no correspondence will be entered into. Each winning entrant will be contacted by SRA and informed that they have won.

- 2.2. After a winning entrant has been notified and confirmed receipt of this notification, SRA will arrange delivery of the prize to the entrant's nominated delivery address. The entrant's delivery address must be within Australia's sugarcane districts (Queensland and Northern NSW).

3. PRIZE INFORMATION

- 3.1. The total prize pool is valued at \$8,000 RRP, consisting of fifty (50) individual prizes being one drum of Nufarm Dropzone herbicide with a RRP of \$160 per drum.
- 3.2. There is a limit of one (1) prize (1 drum) per eligible entrant.
- 3.3. The prize value is correct as at the time of this promotion commencement, no responsibility is accepted by SRA for any variation in the value of the prize.
- 3.4. Prizes are not transferable and cannot be taken in cash. The prize must be taken as described and no compensation will be payable if a winner is unable to use the prize as described.

4. PRIVACY

- 4.1. Under the applicable Privacy Laws, SRA must tell participants when it collects personal information about them and how it plans to use it.
- 4.2. If a participant chooses to complete the survey and take part in the giveaway, the participant will be required to provide SRA with personal information such as the participants name and contact details. SRA collects participants personal information in order to conduct this giveaway and associated research survey. - 4.3. The information collected in the *SRA Weed Survey* about specific weeds on your farm will be kept private.
- 4.4. By participating in the *SRA Weed Survey Giveaway*, all participants provide consent for SRA to enter them in the giveaway and contact them should their entry be successful.

5. PROHIBITED ACTIONS

- 5.1. You may only complete our *SRA Weed Survey* and enter our *SRA Weed Survey Giveaway* for lawful purposes and in good faith. This means that you must not:
 - (i) enter and/or complete the *SRA Weed Survey* more than once; and
 - (ii) do anything that damages SRA's brand, goodwill or reputation.
- 5.2. SRA reserves the right to verify the validity of all entries and reserves the right to disqualify any individual entrant or group of entrants for tampering with the entry process.
- 5.3. SRA's decision is final and no correspondence will be entered into.

6. IDENTIFICATION DOCUMENTS

- 6.1. For winning entrants, SRA may, at its discretion, require the entrant to provide identification documents prior to issuing the prize.
- 6.2. If in such instances, the entrant does not provide the requested identification documents, SRA may at its discretion determine that the entrant is ineligible to receive the prize.

Except for any liability that cannot be excluded by law, SRA (including its officers, employees and agents) will be indemnified of all liability (including negligence), for all personal injury or loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the *SRA Seed Survey Giveaway*, including but not limited to, where arising out of the following;
- a) any technical difficulties or equipment malfunction, whether or not under SRA's control;
 - b) any theft, unauthorised access or third party interference;
 - c) any entry prize claim that is late, lost, altered, damaged or misdirected;
 - d) any variation in prize value to that stated in these Terms and Conditions;
 - e) or use of the prize.
- 9.2. All participants of the *SRA Seed Survey Giveaway*, acknowledge and agree that SRA is not the manufacturer and/or retailer of the Nufarm Dropzone herbicide product (the "Product"). Accordingly, SRA disclaims all warranties with respect to the Product to the fullest extent permissible under applicable law, including without limitation the warranties of merchantability, fitness for particular purpose, non-infringement and title. All participants agree that SRA is not responsible for the performance of the product, and they agree to look solely to the manufacturer of the applicable product for any such claim. This disclaimer does not affect the terms of the manufacturer's warranty for the product, if any.

10. CHANGES TO THE GIVEAWAY

- 10.1. SRA may, without notice, revise or amend these Terms and Conditions from time to time. Continued participation in the *SRA Weed Giveaway* will amount to acceptance of the Terms and Conditions as in force at that time.
- 10.2. SRA reserves the right to, without notice, at any time discontinue or terminate the *SRA Weed Survey Giveaway*.
