### Director Selection Committee

The Director Selection Committee comprises:

- an independent chair appointed by the Board;
- 2 Group G Members nominated by the Industry Peak Organisation; and
- 2 Group M Members nominated by the Industry Peak Organisation.

The Committee's role is to nominate persons for election or appointment as Chairperson and Directors of SRA.

The Committee is assisted by an independent individual or organisation specialising in identification, selection and recruitment of skills-based directors.

The Committee must provide its report to the Board at least 2 months prior to the next Annual General Meeting.

### Eligibility

Any SRA Member Representative may nominate to be a member of the Director Selection Committee.

Director Selection Committee members must have management, selection or board skills as well as industry knowledge.

### Appointment of Director Selection Committee Members

Director Selection Committee members are appointed out of those who nominate by the Industry Peak Organisation, which is currently Australian Sugar Alliance (ASA).

### Remuneration

Director Selection Committee members are not remunerated but may be reimbursed for their reasonable expenses.

### Privacy and Confidentiality
